BOARDING/DOG DAYCARE CONTRACT



ALL 4'S PET CARE OWNERS CONTRACT

This is a Contract between All 4's Pet Care, LLC and the pet owner whose signature appears below (hereinafter called "Owner"). This form applies to all our services but not limited to Luxury Boarding, bathing, training, and other aspects concerning your pet.

1. Owner agrees to pay the rate for dog care provided in effect on the date pet is checked out of the facility. Owner further agrees to pay all costs and charges for special services requested, and all veterinary costs for the dog during the period said dog is in the care of All 4's Pet Care. Owner is also responsible for asking about pricing regarding any of our services.
2. Owner further agrees that the dog shall not leave the facility until Owner pays all charges due or both parties agree upon proper payment arrangements.
3. By signing this Contract and leaving dog with All 4's Pet Care, Owner certifies to the accuracy of all information given about said dog... All 4's Pet Care reserves the right to deny admittance to Owner's dog for any reason at any time.
4. All 4's Pet Care shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If interactive Playful Paws daycare and Group overnight Boarding play is provided, Owner recognizes and accepts potential risks involved in such activity. The Owner further agrees to be solely responsible for any and all acts or behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the dog.
5. Owner specifically represents that he or she is the sole owner of the dog, free and clear of all liens and encumbrances.
6. Owner specifically represents to All 4's Pet Care that, to Owner's knowledge, the dog has not been exposed to any contagious diseases within a thirty-day period prior to check-in. During the period of this Contract, Owner also agrees to notify All 4's Pet Care of any known exposure of dog to a communicable disease and hold dog out of attending All 4's Pet Care until dog is symptom-free for a minimum of 10 days or with written veterinary clearance. Owner further agrees to provide current written proof from your veterinarian of all vaccination records to include Bordetella, Rabies and Distemper as required by All 4's Pet Care policy.
7. All 4's Pet Care shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided by All 4's Pet Care. The owner hereby agrees that in the event the charges are not paid when due in accordance with this contract, All 4's Pet Care may exercise its lien rights upon ten days written notice given by All 4's Pet Care to Owner by certified mail to address shown on contract. All 4's Pet Care may dispose of dog for any and all unpaid charges, at private or public sale, in the sole discretion of All 4's Pet Care, and Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of dog care or other charges delinquent, plus costs of sale, the Owner shall be liable to All 4's Pet Care for the difference. All monies realized by All 4's Pet Care at such sale, over and above the charges due and costs of sale, shall be paid by to Owner.
8. If dog becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, All 4's Pet Care, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the dog, and the expenses thereof shall be paid by the Owner.
9. Owner further agrees that dog is on a preventative flea/tick treatment program and to be financially responsible for any required treatment for fleas/ticks, if determined necessary by the pet care provider. A \$60.00 flat fee will apply to give the dog a flea bath if he/she has fleas. We do this to protect the safety of the facility, dog and staff.
10. All prices and policies are subject to change at anytime.
11. Monday – Saturday check out time is 11:00 a.m. Sunday check out time is 9:30 a.m. Client is billed for the entire day if checked out after the above states times.
12. This Contract contains the entire agreement between the parties. All terms and conditions of this Contract shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and All 4's Pet Care.
